The following Terms and Conditions form part of the Customer Product Purchase Order Form and together with the Product Purchase Order Form constitute the Customer Agreement (the 'Agreement') . The Agreement shall come into force upon acceptance of the Product Purchase Order Form by Alkamedi India, "Selfbiz Mart Pvt. Ltd." on the date of such acceptance ('Effective Date').

### 1. GENERAL INFORMATION CONDITION FOR CUSTOMER

- Please make sure that you and your servicing direct seller sign the Product Purchase Order Form before submitting it to company for processing.
- Please submit proof of identification and address by way of, Aadhaar Card, Election ID, Driving License, Passport, PAN etc.
- Customer status does not entitle the Purchaser to start sales solicitation activities. The product sale activity by a Customer will not be accepted. A Customer Registration is primarily for the purpose of maintenance and after sale service.
- If you wish to start soliciting activities in products of Company you can change your "Customer" status to "Alkamedi India Direct Seller" by following designated procedure to become "Direct Seller".

### 2. ORDERING:

The Customer may place the product purchase order for the Company products or services upon coming into force of this Agreement.

### 3. PRODUCT DELIVERY TIME & METHOD:

- The product will be delivered within 5 - 7 working days by the courier after the "Product Purchase Order Form" and payment confirmation .
- In case of any crisis situation / any statutory requirement is pending from customer side / any departmental issue, it may get delayed until resolution of the respective issues.
- Product delivery charges will be borne by the company.
- You can pickup the ordered product from company warehouse within 3-5 working days of payment confirmation.

### 4. AMMENDMENT OF THE AGREEMENT BY ALKAMED I INDIA:

Company may from time to time amend the Agreement through notice on its website, [www.alkamediindia.in](http://www.alkamediindia.in) If the Customer does not agree to be bound by such amendment(s) , he/she may terminate the Agreement. Otherwise , the Customer's continued relationship with the Company constitutes an affirmative acknowledgement by him/her of the amendment(s), and his/her agreement to be bound by the same.

### 5. DURATION:

This Agreement shall remain valid unless terminated in writing by the Customer or Alkamedi India.

### 6. TERMINATION:

- Either party may terminate this Agreement by giving written notice to the other.
- Alkamedi India may terminate this Agreement forthwith for cause or due to legal or regulatory requirements by giving a written notice to the Customer .
- The Agreement shall terminate automatically, with immediate effect, in the event that the Customer is appointed as a Direct Seller.

### 7. CONDITIONS FOR SALE:

Ordering and Invoices: The supply of Products by the Company under an invoice shall be subject to the following provisions:

- Weights, measures and statements as to quantity, quality, date of manufacture and other descriptive data as contained in the packing shall be presumed to be correct.
- The Customer shall have legal title to the Product when it is handed over to the Customer or the Carrier, as the case may be.
- Prices are inclusive of all taxes as on the date of sale.
- The Customer must verify conformity of the Product with the order before accepting delivery.
- Company is not liable for delays or non-delivery of Products by the carrier due to Force Majeure or other circumstances beyond its reasonable control, or any direct or indirect loss of damages arising therefrom .

### 8. SERVICING DISTRIBUTOR (SPONSOR) :

The Customer agrees that a Servicing Distributor (Sponsor), if not indicated on the Product Purchase Order Form, will be assigned to him/her by the company. The Customer hereby consents to permit the Servicing Distributor (Sponsor) ,to contact him/her in relation to products offered by the Company, including notifications of promotions, and to the transfer of his/her data to the Servicing Distributor (Sponsor) , in accordance with the Privacy Policy. The Servicing Distributor (Sponsor) ,will be available to assist the Customer with Product information, purchases, refunds or complaints.

- Self-Consumption : The Customer agrees that he/she shall use the products purchased from the Company for his/her self consumption only, and shall neither resell the products nor use the same for any commercial purpose.
- Returns:** Returns and refunds are subject to the Company Refund Policy available in the Policies and Procedures Handbook.
- Severability:** If any provision of these Terms and Conditions is declared invalid or unenforceable, the remaining provisions shall remain in full force and effect.
- No Assignment:** This Agreement is entered into on a personal basis, and neither this Agreement nor any of the rights or obligations of the Customer arising hereunder may be assigned or transferred without the prior written consent of the Company.
- Companies Liability whether under contract or otherwise, arising out of or in connection with this contract shall not exceed the less of a) actual damages or loss accessed by the arbitrator; b) the total price of the product purchased.
- Any dispute arising out of this Agreement or in any manner touching upon it, the same shall be settled through arbitration under Arbitration and Conciliation Act 1996 with all statutory amendments, by sole arbitrator to be appointed by a Director of the Company, who may be specifically authorised by the Board of Directors of the Company in this regard. The venue of arbitrator shall be Udaipur.
- Governing Law:** This Agreement and all questions of its interpretation shall be governed by and construed in accordance with the laws of the Republic of India.
- Jurisdiction:** This Agreement and all transactions between the Company and the Customer hereunder are subject to the exclusive jurisdiction of the courts at Udaipur.
